YOUTH & AMATEUR TEAMS CHALLENGE

The Youth and Amateur Teams Challenge program is an event to promote camaraderie but will offer a demonstration of the skill that Youth and Amateurs alike boast.

The Youth and Amateur Teams Challenge will consist of four (4) members which are to be drawn randomly. No Teams are to be pre-organised.

If you are interested in being placed in a Team then nomination for either of the 2 Challenges must be on the official forms provided and are to be accompanied by a fee of \$5.50 per Team Member.

THE CHALLENGE

Each Team Member may nominate two (2) events only, in which the points will tally towards the Team High Point. Team Members may use one (1) or two (2) horses as per AQHA Rules and Regulations. The events for each Team Member will be decided once the Teams have been organised.

All AQHA Rules and Regulations apply but not limited to those pertaining to Youth and Amateur Competition refer to Sections 61 and 62 of the AQHA Official Handbook.

Each discipline is judged as per AQHA Rules and Regulations. Teams are to be presented in full show attire, with each member dressed according to AQHA Rules and Regulations for their respective discipline.

Points will be allocated on a 6, 5, 4, 3, 2, 1, or pro-rata if less than six (6) entrants per class.

All Youth, Amateur & Select Amateur events at Q12 are eligible for points to be counted towards the Team Challenges.

Awards will be presented at the completion of the Show, along with the Q12 High Point presentations.

I acknowledge and agree that a Standstill is a risk of participating in this event and agree that I will pay any costs or expenses incurred by the Organising Committee for or on behalf of my horse and myself/horse handler or as a result of a Standstill.

In consideration of the Organising Committee accepting my Entry Forms to participate in the Event, I, to the extent permitted by law:

- a) Release and will release Organising Committee from all Claims that I may have or may have had but for this release arising from or in connection with a Standstill and/or my participation in the Event; and
- b) Indemnify and will keep indemnified Organising Committee in respect of any Claim by any person arising as a results or in connection with a Standstill and/or my participation in the Event.
